Correction on Early Voting Information

In last week's Jan. 14th issue of the 'Fowlerville News & Views', the article on 'Handy Township purchasing former Woodshire Place to use as voting site' had some incorrect information regarding early voting requirements.

As a result of approval by voters of Proposal 2 in the 2022 election, Michigan has expanded the number of days that on-site early voting can take place prior to Election Day, starting on the second Saturday before an election and ending the Sunday before the election—a total of nine days.

Election law, however, allows each Clerk of a Township or City to set their own hours for early voting. The Handy Township Clerk has decided to be open at the former

Woodshire Place (6520 Grand River) from 11am to 7pm on those early-voting days. However, other area Clerks can establish their own hours during this voting time frame.

With the Michigan Presidential Primary coming up next month, those times will be posted, along with the voting sites.

The Centeredness of Self-Confidence

Last week, I contrasted greater purpose and self-absorption. To describe the positions, I used several “self-” phrases, but you may have noticed that I did not once refer to self-confidence. That likely seemed a little strange since, admittedly, the issue of self-confidence stirs right below the surface of last week’s topic, but I refrained from the term on purpose. I hoped to avoid readers conflating self-confidence exclusively with either of the two positions.

The issues raised in last week’s article are closely related to self-confidence, but it is independent enough to warrant a separate examination. A common contemporary definition of self-confidence is that it comes from elevating self. This

seems to make sense prima facie. After all, if we are talking about confidence in self, then the more we idolize ourselves, the greater our confidence will be. According to this characterization, we should prioritize what we want and try to turn the spotlight on ourselves. The attitude is “look how wonderful I am,” even if we are not always so wonderful.

This sounds similar to how I described self-absorption last week, so does that mean I am opposed to self-confidence? I fear some readers may have thought so, despite my best effort to remove that confusion. So, to be clear, no. I do not oppose self-confidence. In fact, the thought of opposing self-confidence seems downright silly. We need self-confidence to navigate life. Without it, we would never pursue great things or even make it out of bed in the morning! I advocated last week for greater purpose, and that requires self-confidence.

What I am opposed to is self-centered confidence. The difference in definitions is critical. When we misunderstand the basis of self-confidence, we open ourselves up to disappointment, frustration, and heartache. Rather than an idolization of self, effective self-confidence is a calm but determined resolution in the right. It is principles-based rather than accomplishment-based. No matter how much we try to pump ourselves up, we will eventually disappoint ourselves and others because none of us are perfect. But if we choose sound principles, we can remain confident “in the right as God gives us to see the right,” as put by one great American.

Self-centered confidence creates a fragile self-identity. If someone’s self-absorption bubble is popped, then what remains to keep them fulfilled, happy, and confident? In the same vein, self-centered confidence makes personal growth difficult. Why should I mature or improve as a human being if I am already perfect just the way I am?

However, if we instead ground self-confidence in firm principles and purpose, we can endure, remaining steadfast in the midst of harsh adversity. This is important if we want to survive life’s many complexities and hardships. Those who argue that self-confidence is something we must prioritize and develop are not wrong. It is something we should instill in our children and even in each other, but I hope we do so by building on a solid foundation.

The Big Red Barrel will be at Recycle Livingston on Saturday, Feb. 3, from 9 am to 1 pm to collect unused medications and used needles. Recycle Livingston is located at 170 Catrell Drive in Howell.

This is a free service. No questions asked. Put pills in a zip lock container, they can be mixed together. We prefer not to have the medicine container. Keep liquid medications separate. Dump into a zip lock bag with enough paper towel to soak up the liquid. Needles must be in the proper disposal container, either purchased from a pharmacy or use a plastic laundry detergent bottle. Reseal the bottle and tape it.

Do your part to keep medications from being abused. Do not flush unused medication. The Big Red Barrel Project is part of Livingston County Community Alliance.

Snow— Fertilizer & Rest

Recently I posted on one of my social media accounts that I was thrilled we had finally received a significant amount of snow. Unsurprised, I read numerous comments that agreed with me as well as those who accused me of being crazy (in good natured teasing).

Last week I wrote about snow, using scripture as word pictures how God describes our sins when they are removed. This week, I took a look at the practical side of why it's important for us to have snow covered ground during the winter months.

From the site almanac.com this is what they have published:

- Both rain and snow contain nitrogen that plants need, but snow by its nature provides a better delivery method. Nitrogen attaches to snowflakes as the snow falls through the atmosphere. In addition, nutrients are slowly released into the soil as the snow melts. This is especially effective early in the spring when the ground is thawed, allowing nature to provide

a gentle fertilizer boost to plants!

- Snow is mostly air surrounded by a little frozen water, and despite how cold it feels to the skin, it is an excellent insulator of the soil and plant roots.

- Snow protects against wide temperature fluctuations in the soil. Under that cozy comforter of white, the roots of perennials, bulbs, ground covers, and strawberry plants are protected from the freeze-thaw cycle that can heave tender roots right out of the ground. Without snow, milder temperatures and the sun could warm the soil surface, leading to damage from soil heaving, which can break roots and dry out plant parts.

- Snow is winter mulch

- If you didn't get around to mulching your garden this past fall, a nice blanket of snow can serve the same purpose!

Never remove snow from your yard—it's Mother Nature at work. Snow cover is valuable winter protection for your expensive trees and shrubs.

Once again, science and the divine meet in agreement with these words from the prophet Isaiah. "The rain and snow come down from the heavens and stay on the ground to water the earth. They cause the grain to grow, producing seed for the farmer and bread for the hungry." (Isaiah 55: 10)

In addition, how many of us can deny we weren't excited for a "snow day" when we were attending school? And, why as adults do we still enjoy these unexpected days of rest? Personally, I've asked myself that very question—"Sue, why do you "love" being snowed in?" So, I typed that question in my search engine. Lo and behold I found a wonderful quote by Helena Fitzgerald! "For adults, snow days feel like divine permission to rest" and "unexpected time off after a snowfall feels like a gift because it removes the pressure to be productive".

As someone who considers herself to be a life-long learner, I'm very pleased to have science teach me about the practical benefits of snow along with the affirmation that a beautiful blanket of knee deep snow causes my heart to jump with joy! Yes, I also acknowledge there will always be folks in my circle of friendship who may scoff at my unabashed love for snow. My response to them and anyone mumbling against its beauty is simply the words from Psalm 118: 24 "This is the day that the Lord has made; we will rejoice and be glad in it."

The next time you're home under a big snow storm, rest. Take a much needed break from daily demands. Read a book. Watch a good movie. This spring and summer, when it's planting time, thank God for the free fertilizer He poured out on your garden soil and flower beds. And, if an attitude adjustment is necessary—rejoice! "A happy heart is good medicine, but a broken heart dries up the bones." (Proverbs 17: 22)

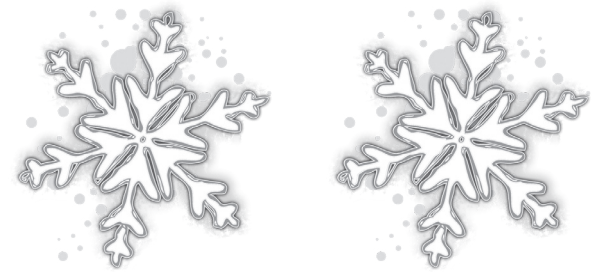

NOTICE OF ADOPTION OF THE CONWAY
TOWNSHIP ORDINANCE ESTABLISHING
A FIRE CODE**

The Conway Township Board of Trustees, at its December 19, 2023, meeting has passed the Conway Township Ordinance to Establish a Fire Prevention Code Ordinance (Ordinance No. 28). This ordinance is summarized as follows:

SECTION 1 establishes for Conway Township a Fire Prevention Code by adopting the International Fire Code, 2021 edition, including all Appendices, as published by the International Code Council.

SECTION 2 states the purpose of the Ordinance.

The purpose of this ordinance is to adopt the Fire Prevention Code as an enforceable regulation governing the safeguarding of life and property from fire and explosion hazards arising from the storage, handling and use of hazardous substances, materials and devices, and from conditions hazardous to life or property in the occupancy of buildings and premises.

SECTION 3 provides who is to serve as the fire code official and also outlines the appeals process

1. The fire code official shall be the Fowlerville Area Fire Authority Chief, or their designee.
2. Any appeals shall be made to the Conway Township Clerk. The Conway Township Board of Trustees shall appoint 3 members to serve as the Board of Appeals pursuant to Section 111 of the Fire Prevention Code.

SECTION 4 outlines that a complete copy of the Fire Prevention Code shall be kept in the office of the Township Clerk.

SECTION 5 offers guidance for conflicts between any of the provisions of the Fire and other regulations.

SECTION 6 outlines fees assessed for any second or subsequent re-inspection.

\$100.00 per re-inspection after the second inspection.

SECTION 7 provides for penalties when Fire Inspection Code provisions are violated. The sanction for a violation, which is a municipal civil infraction, shall be a civil fine in the amount as provided by this ordinance, plus any costs, damages, expenses and other sanctions.

- (1) The civil fine for a violation shall be a minimum of \$100 and a maximum of \$500, plus the cost and other sanctions, for each infraction.
- (2) Increased civil fines may be imposed for repeated violations. As used in this section, "repeat offense" means a second (or subsequent) municipal civil infraction violation of the same requirement or provision (i) committed by the same person within a 24-month period and (ii) for which the person admits responsibility or is determined responsible. The increased fine for repeat offenses shall be as follows:
 - a. The fine for any offense which is a first repeat offense shall be a minimum of \$250 and a maximum of \$750, plus costs.
 - b. The fine for any offense which is a second repeat offense or any subsequent repeat offense shall be a minimum of \$ 400, and a maximum of \$900, plus costs.

SECTION 8 provides for payment of any fees or violation fines shall be paid to the Fowlerville Area Fire Authority.

SECTION 9 provides authority to the Fire Chief, and their designee, as well as the Conway Township Ordinance Enforcement Officer to issue tickets for violations of the Ordinance.

SECTION 10 provides for additional fines when failing to comply with this ordinance. Any person who shall continue any work after having been served with a stop work order, except such work as that person is directed to perform to remove a violation or unsafe condition, shall be liable for a civil infraction per Section 7 and a minimum fine of \$25 and a maximum fine of \$500.

SECTION 11 provides authority for the Fowlerville Area Fire Authority to collect unpaid debt in an appropriate court of law.

SECTION 12 provides that if any portion of this Ordinance is found to be void or unenforceable, the remainder of the Ordinance stays in effect.

SECTION 13 requires the Conway Township Clerk to publish notice of this ordinance adoption.

SECTION 14 states that this Ordinance is effective 30 days after publication.

Fred Moon, one of the regulars, noted that cribbage is popular in the Upper Peninsula, hence the reference to

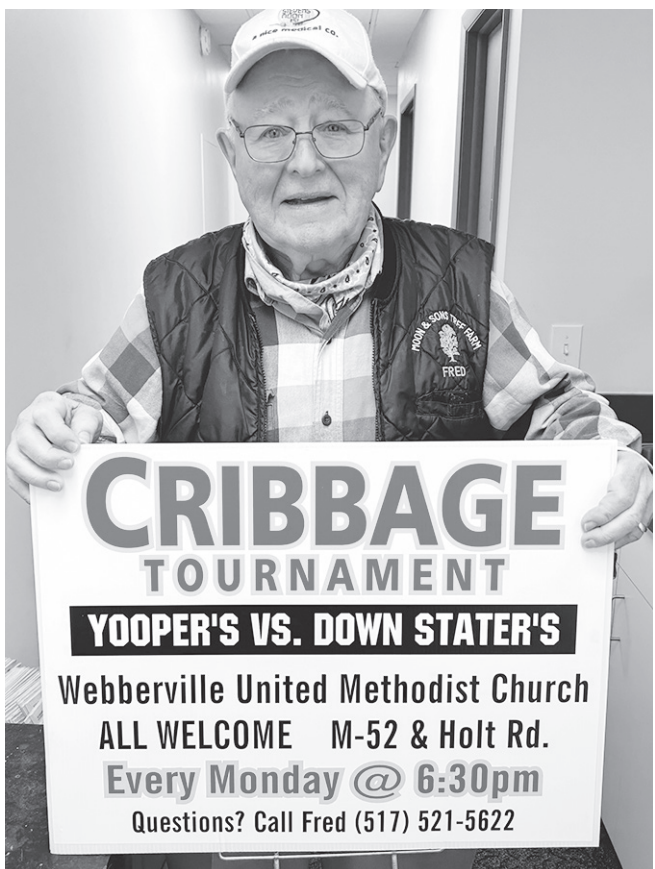
Yoopers.

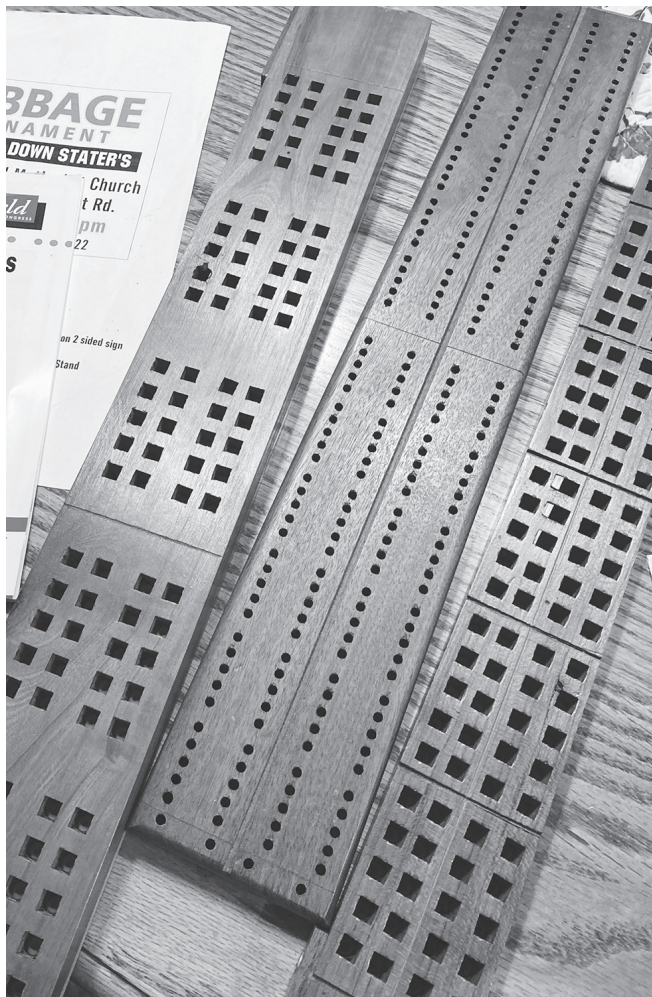
Moon described the competition as "friendly, with players helping each other when someone misses points."

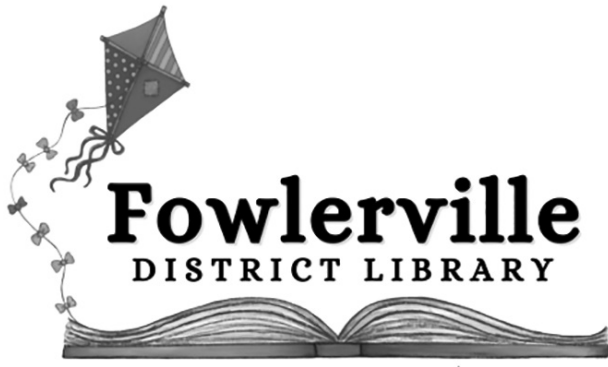

Michigan House Report

Michigan’s fiscal and economic leaders met for the annual January Consensus Revenue Estimating Conference on Jan. 12, projecting higher-than-expected state revenues that will result in a \$1.3 billion budget surplus this year.

Republicans in the House were very quick to call for an income tax cut to help offer some relief to people who are still struggling to afford the higher cost of living. You might recall that the state income tax rate increased from 4.05% to 4.25% on Jan. 1 after the governor and the attorney general took action to end the reduction that occurred in 2023.

Unfortunately, just a couple of days after news of the budget surplus broke at the Consensus Revenue Estimating Conference, Gov. Whitmer told reporters she would not consider lowering taxes.

In 2023, the state started the year with a \$9 billion surplus. The governor and Democrats in control of the Legislature blew through it all, spending it on corporate handouts and other special projects to help their political allies. Meanwhile, families continue to pinch pennies to put groceries in the fridge and pay their monthly bills. If the state has a budget surplus, we should give it back to the taxpayers to whom it rightfully belongs.

In addition to putting more money in everyone’s paychecks, lowering the income tax would greatly benefit our economy, which seems to be lagging behind other states.

According to data compiled by the Mackinac Center for Public Policy, jobs in states that tax income is at less than 4% are up 5.7% above their pre-pandemic levels. In states that tax income is at 4% or higher, job numbers have only increased by about 2% since the pandemic. Michigan is even further behind, with the state still 0.6% below its pre-pandemic job numbers, according to the latest payroll jobs data from the Bureau of Labor Statistics.

The first two weeks of a 54-54 split in the Michigan House of Representatives have been a bit of a learning curve for House Democrats who are used to being in control.

On Wednesday, Democrats rushed a vote on an amended bill without giving my Republican colleagues and me much notice about the changes. It ended up failing 52-52.

I hope this will serve as a lesson that working together in an open and transparent manner is the only way we will get anything done in the current environment. The Democrats’ days of operating in secret and ramming through partisan policies are over. It’s time for the Democrats to come to the table and discuss how to share power and what policies we can pursue together to make life better for people throughout our state.

On a positive note, the 54-54 split helps stop the Democrats from passing any radical bills.

Michigan DNR Showcase— Add More Outdoors to Your Life in 2024

When it comes to nature-based fun and learning, we've got you covered. Everyday adventurers, weekend warriors and everyone in between – you're all welcome in Michigan's big green gym.

"No matter where you live or where you'd like to go,

our state has a wealth of quality public lands offering many opportunities to get you outside," said Scott Whitcomb, director of the Office of Public Lands at the Michigan Department of Natural Resources. "If your 2024 plans include resolutions for better physical and mental health, less screen time and more days enjoying, supporting and learning about the outdoors, this is a pretty great place to be."

Here are a few ideas to get started.

TACKLE NEW TRAILS

Michigan has more than 13,400 miles of state-designated trails, including multi-use trails that can accommodate more than one type of recreation use. These trails are for hiking, biking, cross-country skiing, paddling, horseback riding, off-road vehicle riding, snowmobiling and more. To tweak your trails routine:

- Try a new trail at least once a month.
- Paddle one of nine designated state water trails (totaling 630 miles) that flow through more than a dozen counties.
- Sign up for the Bob Ross-inspired Happy Little (Virtual) 5K (April 22-26) and support tree-planting and forest-protection efforts in state parks.
- Bring a buddy and introduce someone to the trails experience.

When you're ready to blaze your own trail, get everything you need – interactive non-motorized trail and ORV route maps, snowmobile trail maps, track chair details, etiquette guidance and closures info – at Michigan.gov/DNRTrails.

WATCH FOR WILDLIFE

An easy, fun way to enjoy fresh air is to keep an eye out for animal tracks. You can do this year-round, but with tracks and evidence of critters more visible with snow on the ground, winter is one of the best times.

Rachel Lincoln, a DNR wildlife outreach coordinator, said many animals remain active during Michigan winters, both in urban and rural settings, and it's common to see tracks of deer, squirrels, coyotes, birds and rabbits widespread throughout the state – though the tracks of bobcats, foxes and weasels prove more elusive.

"Small mammals such as shrews, mice and voles will tunnel beneath the snow, leaving lines of raised snow that are easy to spot," she said. "Following tracks gives insights into animal behavior. You're like a detective, piecing together what the animal was doing, where it was traveling to and from, whether it was alone or traveling in groups."

TRY YOUR HAND AT TREE ID

With more than 20 million acres of forest land and expanding urban tree canopy, Michigan knows trees ... but do you? Hartwick Pines State Park interpreter Craig Kasmer has some tree-identification tips to keep in mind when you're out exploring.

Conifers (pine, spruce, fir and cedar, for example) that retain their leaves are easier to ID in the winter. Deciduous trees (like maple, birch and elm) that lose their leaves take more effort to determine.

"The three characteristics to look for are bark, branching and seeds, and the seeds are usually found on the ground at this time of year," said Kasmer.

For a branching reminder, he suggested the acronym **MAD HORSE**, because **m**aple, **a**sh, **d**ogwood and **h**orse chestnut all have opposing branching patterns: twigs grow off a branch opposite of each other like our arms from our torso. All other trees/shrubs grow in an alternate pattern.

Some quick tree traits: White oak trees have water-resistant properties that make them great for building boats and wine barrels. Redbud trees have tiny pink flowers that bloom before the trees even grow leaves. The mighty eastern white pine, Michigan's state tree, can grow over 100 feet tall!

KNOW YOUR INVASIVES

No matter how or where you spend time outdoors, there is something you can do to care for your favorite places: learn about invasive pests and diseases that threaten native plant and animal species.

If certain invasives are given the chance to outcompete native species enough to establish themselves in new ecosystems, they pose a huge risk to Michigan woods and water. Certain species can cause deforestation, reduce fish populations and alter valuable habitat.

It's easy to help; just know what to look for and report what you see!

Visit Michigan.gov/Invasives to learn more about identifying and reporting problem species; get tips on actions hunters, anglers, boaters and others can take to reduce the spread of invasives; and explore the popular *NotMiSpecies webinar series*. It covers everything from rock snot (yes, a true aquatic invasive species) to protecting your own backyard or neighborhood from damaging bugs like spongy moth or spotted lanternfly.

VOLUNTEER

Teaching new hunters about safety, answering campers' questions and sharing campground program information, pulling invasive plants in state parks' natural areas, cleaning up illegal dumping sites in the forest, installing fish-spawning structures, gathering water samples from an inland lake, giving lighthouse tours, reporting sick or dead wildlife – these are all things you can do to help Michigan's natural world and the people who like to spend time in it.

If you want to lend a hand but aren't sure how to make the leap, visit the DNR's Get Involved webpage. Explore the different volunteer options and see where you have a natural inclination, what feels like the right fit. If Michigan's great outdoors has given a lot to you over the years, make 2024 the year you give back. You'll be glad you did.

DISCOVER NEW PURSUITS

Always wanted to try fishing, hunting, hiking, birding, mushroom hunting or other nifty nature quests, but want a little guidance? The DNR's Outdoor Skills Academy has just what you need: expert-led outings, all the gear, and time and space to let yourself learn.

"Sometimes a lack of experience with a certain hobby or skill can be intimidating, but the Outdoor Skills Academy removes all of that," said the DNR's Ed Shaw, who oversees the program. "Spend a weekend with your son or daughter, partner or best friend – or go solo and make new friends – and enjoy diving into something new that might just become a lifelong passion."

Upcoming classes include ice fishing and snowshoe building, with more opportunities added throughout the year. Watch for updates and registration details at Michigan.gov/OutdoorSkills.

Michigan's Becoming an Outdoors-Woman program offers women (18 and older) opportunities to explore outdoor activities in a noncompetitive, supportive atmosphere. The program offers weekend events in February and June in the Upper Peninsula at the Bay Cliff Health Camp north of Marquette.

"BOW truly is a life-changing experience for many of the participants who often find deep and meaningful connections to the outdoors on their very first visit," said John Pepin, administrator of the program. "There is also a camaraderie, finding of new friends and good times shared by participants and volunteer instructors alike."

The program has dozens of class offerings ranging from self-confidence, shotgun and rifle shooting and cross-country skiing to fly fishing, paddleboarding, photography, wilderness first aid, archery, backwoods cooking, hiking and more. Sign up for upcoming activities and learn more at Michigan.gov/BOW.

LOOK LOCAL

Whitcomb said that state-managed public lands aren't your only option for getting outdoors. At the local and regional levels, too, you can find quality public recreation resources – neighborhood playgrounds, nature centers, community parks, city-to-city trails and more – that often are available closer to home.

"Such opportunities proved critical during the COVID-19 pandemic, and they continue to provide the safe, welcoming outdoor space people value," he said.

One place to start the search is the DNR's Michigan.gov/YourLocalOutdoors website, where you'll find an interactive map pin-pointing the names, locations, directions and destinations for plenty of places to camp, hunt, fish, boat, bike and more. Most entries offer information such as latitude and longitude, address, contact phone number and link to a dedicated webpage with more specific details and amenities.

Get more outdoor inspiration – including winter fun such as fat-tire biking, stargazing and cross-country skiing – on the DNR's Things to do webpage.

If you're looking for new opportunities for adventures and recreation in the outdoors, Michigan has what you're looking for. Add more outdoors to your life in 2024.

Class of 2024 Parents/Guardians and students,

Class of 2024 FAFSA Update. The Federal Government has announced that the updated FAFSA will be open for applicants by 12/31. Before you stop reading, please remember that Michigan is a state that uses the FAFSA application for all State Scholarships and Grants as well as some college scholarship opportunities. This is free money that does not need to be paid back and can be used at trade schools, certificate bearing programs, community colleges, as well as 2–4-year universities and colleges.

At the start of the year, we were informed that all a student would need to complete their portion of the FAFSA was their contributor’s (Parent/Guardian) name and email. With this information, we walked the students through Step 1: Getting their Student Aid ID. We also booked a financial aid specialist to host a workshop during the school day to walk students through completing their application. Unfortunately, the Federal Government is now requiring students to have their contributor’s social security number among other items. Knowing parents/guardians would not want their students to have this information we need to pivot our plans.

In lieu of the in-school workshop, we have booked an online event with a financial aid specialist that was held on 1/17 at 8pm. This way the specialist will be able to walk you and your student through the process from the comfort of your home without the concern of your social security information being in the hands of a high school student. This event is only for Fowlerville Seniors and their families (please see email from 12/4 for FAFSA and workshop links). All questions can be answered, especially ones like who should be the contributor, divorced families, guardianship as well as tips and tricks to get the most aid.

It is our goal that all graduating seniors have the tools available to take their next steps after high school. One of the most difficult conversations we have with students and their families is about missing deadlines for things like financial aid, or when a student changes their mind from entering the workforce and wants to attend a trade school or community college and have not taken the necessary steps to help pay for it.

We hope you take advantage of this opportunity. We
