A Fowlerville woman recently reconnected with a boy she'd helped 50 years ago thanks to Facebook.

“Stupid Facebook” is a phrase I’ve said many times before,” said Cindy (Ruttman) Krebs. “But there is something good that has happened to me because of Facebook. I told my story to a friend; she loved it and encouraged me to share it with others.”

Fifty years ago, in the Fall 1976, Cindy Ruttman made a decision that would change the life of a young Nepali boy.

The story, she noted, actually began years before when her parents, Bob

**Former Fowlerville Fire
Chief John Wright passed
away last Wednesday;

Former Fowlerville Fire Chief John Wright passed away last Wednesday, Jan. 28, after an extended illness. The news was reported by his successor, Bob Feig.

Wright served as chief for 34 years and was a member of the local department for 50 years. He began as a

firefighter, was promoted to captain and then in 1981 was named as the assistant fire chief by the then chief, Maurice Bohm. Five years later he was hired to replace Bohm who had resigned from the position, with Wright beginning his duties on March 1, 1986.

He remained in the position until retiring in February of 2020.

Feig, who was one of Wright’s first hires and eventually became his deputy chief, noted that John saw the department through a lot of changes.

“He was with the fire department when they moved from where the

Lady Bird Deeds: A Simple Planning Tool More Families Should Know About By Aaron Franks, "Aaron the Funeral Guy"

When families sit across from me during an arrangement conference, we're usually talking about honoring a life and making immediate decisions. But inevitably, other questions come up too. Questions about homes, property, and what happens next. One document families can have in place ahead of time is something called a Lady Bird deed.

It's not a complicated concept, but it can make a world of difference.

A Lady Bird deed, also known as an enhanced life estate deed, allows you to keep full ownership and control of your home while you're alive, and then automatically transfer that property to your chosen beneficiaries when you pass away. The key word there is *control*. You don't give up ownership. You don't lose the right to sell, refinance, or change your mind. You remain the owner until death.

Nothing changes in your day-to-day life. You live in your home, pay your taxes, insure it, and maintain it just as you always have. The transfer only happens after death, and when it does, it happens without probate.

That alone is reason enough for many families to consider one.

A common question is how many beneficiaries can be listed on a Lady Bird deed. The answer is simple: you can name more than one. Many people list all of their children, sometimes grandchildren, or a combination of both. You can also specify how the property should be divided, equally or in specific percentages, so there's no confusion later.

And if life changes? You can change the deed. As long as you're living, you can amend it, revoke it, or replace it entirely.

So why is having a Lady Bird deed such a good idea?

First, it avoids probate for your home. Probate can take months, sometimes longer, and it often adds stress, delays,

and expenses during a time when families are already overwhelmed. A Lady Bird deed allows the home to pass directly to the beneficiaries you chose, without court involvement.

Second, it provides clarity. Everyone knows what's supposed to happen, and there's far less room for misunderstandings or conflict. I've seen firsthand how unclear property ownership can complicate everything from funeral arrangements to estate settlement.

Third, in certain situations, it can help with Medicaid planning because ownership remains with you during your lifetime. This is something that should always be discussed with an elder law or estate planning attorney, but it's one of the reasons Lady Bird deeds are commonly recommended.

From where I sit, anything that reduces stress for families after a death is worth talking about. A Lady Bird deed doesn't replace a will or a trust, and it's not right for everyone, but for many people it's one of the simplest and most effective planning tools available.

As always, my goal isn't to tell anyone what they *should* do. It's to help families understand the options that exist so they can make informed decisions long before they're forced to make them during a difficult moment.

If you've never discussed a Lady Bird deed with an attorney, it may be worth adding to your to-do list. Your family will thank you for it later.

CONWAY TOWNSHIP NOTICE OF ORDINANCE ADOPTION

TAKE NOTICE that on January 20, 2026, the Township Board of Conway Township, Livingston County, Michigan, adopted "An Ordinance to Amend the Zoning Ordinance to Add Aircraft Camping as an Accessory Use to Airports" (the "Ordinance").

The Ordinance is available for inspection at the Township Hall, 8015 N. Fowlerville Road, Fowlerville, MI 48836, during regular business hours. Copies may be obtained for a reasonable charge. The Ordinance takes effect seven (7) days after the date of this Notice. Below is a summary of the Ordinance.

SUMMARY OF THE ORDINANCE

Section 1. Amendment to Section 6.23. New subparagraph "E" is added to the existing Section 6.23 of the Zoning Ordinance. It allows for limited camping activities directly associated with aviation tourism at airports and provides regulations for that land use.

Section 2. Validity and Severability. The Ordinance's provisions are severable.

Section 3. Repealer. Any ordinance or parts thereof that conflict with the Ordinance are repealed to the extent necessary to give the Ordinance full force and effect.

Section 4. Effective Date. The Ordinance takes effect upon the expiration of 7 days after publication.

and Lydia Ruttman, would host foreign exchange students on their family farm from all over the world. This, in turn, created an interest with them joining the Peace Corps.

"In 1974, they enlisted and were sent to Kathmandu, Nepal, where my dad, Bob, taught Nepali people about agriculture and my mom, Lydia, worked as a secretary for a world aid organization," Cindy said.

Before their enlistment was over, Cindy, her sister Becky, niece Dianne, brother Mark and his future wife Kate, made the trek to Nepal to visit them. While there, Cindy met a man named Marc Ross, another Peace Corps volunteer, who was stationed in the mountains of Nepal.

"Ross was looking for people to financially sponsor the education of Nepali children and I decided to help out," Cindy said.

The child she was assigned to was a nine-year-old boy. Over a few years' time, Cindy supplied the boy with the funding he needed to complete his schooling. In addition to money, Cindy would also send him gifts, like hats for winter. Eventually, her assistance ended and contact was lost.

One day this past November, Cindy was scrolling through Facebook when she received a notification in her private messages. The message was from someone named Ramsharan Harisharan from Nepal. Even though he mentioned her parents, as well as the man who set up the sponsorship, Cindy didn't recognize the name and, being cautious, she ignored it.

The messenger persisted.

Eventually, curiosity won and Cindy contacted a Peace Corps' member in New York who was stationed with her parents and confirmed that Marc Ross was the man she had met in 1976 and the boy who she sponsored was indeed Ramsharan.

So, she finally answered the message and made contact.

What she learned is that Ramsharan is now fifty-nine

years old, newly retired from a bank in Kathmandu and is now venturing into financial consulting. He is married and has two sons, who have both studied in the United States.

In the message to her, Ramsharan said "Finally, God helped me to reconnect with you."

He went on to say that he had thought of Cindy often and had taken time to search for her over the years to thank her for her generosity.

Thanks to Facebook, a fifty-year-old reconnection was made for two people who, although they lived a world apart, had made a positive impact on each other's lives.

Ah, snow days. Who doesn't like a good occasional break from winter's routines with weather that can interrupt and

bring life to a fast standstill. And while such storms have their fair share of dangerous opportunities and mishaps, personally I find that the feelings that well up inside me when I hear of snow days for kids and teachers in our schools, still evoke a certain satisfaction inside me. And, because I don't have a job or career that takes me outside the home anymore, I find I'm quite content to be home in comfort and away from any of a storm's harsh realities. So it is this past week that I've paid attention, waiting to hear or read about cancellations, which takes me back to memories from childhood, when winter storms created snowdrifts up our back door, impassable streets and sidewalks.

When I was a child, we relied on our local television networks to broadcast weather. Much anticipated school closings were announced using a message tape that ran across the bottom of the TV screen. In our home, it was my dad's

routine to tune in "The Today Show" for the morning news. Invariably, if a pounding snowfall began in the night, I was up in the morning my usual time, still getting ready for school, but anxiously watching the television for the answer to my prayer—"please God! Let it be a snow day".

Often, I was disappointed when the ticker message didn't include Saginaw City Public Schools. Alas, meaning I kept getting ready. In elementary years we walked two blocks to school. By the time junior high years arrived dad dropped me at my best friend's home and we walked together, covering more than two blocks to our building. In high school, dad often drove me or dropped me at a corner where us kids could catch a city bus which was chartered for transporting students (there was no school bus operation in the late 60s and 70s). When my best friend could drive, she used her family car to get us to school, rain, shine and snow.

Those days are long gone now for me, yet I can still pull images from my memories of snow days that involved a lot of shoveling, snow forts, snowball fights, piles of snow on every corner and along driveways. There was one year that the pile of snow dad and my brothers created from clearing the drive was so big that us kids were able to mold it into an igloo complete with digging it out for a couple of us to crawl inside. If memory serves me correctly we may have even sprayed it down with water to form a good ice covering, but then that would mean my memory says the

I certainly am not wishing for another blizzard like the one in '67 but I will say this, all these years later I still enjoy a good snow storm. I can brew a cup of tea in the afternoon, layer myself under a throw blanket, and watch nature's beauty from a window, seemingly endless pure white flakes falling and cascading in the air, landing on our pines, painting portraits of perfection. And, much like when my family stood at our living room window watching Tommy in his Chevy Nova, listening to him rev the engine, all of us giggling at his "foolishness", wondering if he'd indeed win the battle against a looming snow drift, I smile. I breathe sighs of contentment and happiness. "These" current snow days are very different from my childhood but one thing remains. The peace, awe, and wonder from winter's offerings always overshadow anything else going on that's less than pure joy for my own "snow day" at home!

He spent many years taking care of his beloved grandmother, Edna Gardner, until she passed peacefully at the age of 108. He will be remembered as a man of quiet strength, full of love and compassion for his family and everyone, and for always whistling while he worked.

In his younger years, John was an avid traveler – taking the motorhome road tripping and camping across the country. He also served as the Head of the Livingston County Arson Investigation Team. Even late into his retirement, you could expect to hear "How are you, Chief?" and "Hey, Chief Wright!" when he walked by. John will be remembered by his community and family as a man of positivity, strong work-ethic, and integrity.

Handy Township office is now to the 200 North Grand Avenue location," Feig said. "He helped with the construction as the firefighters pitched in to finish that building. And he was in charge when we built the South Station on South Fowlerville near Sargent Road. He was also the chief when we first started looking for a site for a new fire station, given that we had outgrown our North Grand Avenue station."

But along with being part of these relocations, Wright also oversaw the transaction of the department from volunteers with minimum training who mainly fought fires and assisted the community in local events to one that provides emergency services, has several on-site staff members, and undergoes continuous training to upgrade their skills.

"Fire service is quite different now than when John started," said Feig. "He played a key role in taking the department to a new level with our skills and taking on the additional duties like providing emergency services."

Feig noted that Wright and his then assistant fire chief Jim Porcello trained hundreds of firefighters, including those in Fowlerville as well as neighboring departments. Feig, when he became assistant chief, assisted in those sessions.

"There was a tragedy back in 1986 where three firefighters were killed in a training accident and this resulted in a huge change on how we train and safety precautions," he said. "The terrorist attack in 2001 was a monumental shift in the way fire departments trained and the type of training that we had to have. And it's still, it, it just keeps increasing."

"John was very instrumental through the 1980s and 1990s and into the 2000s in this effort," he added. "A lot of that training was held right here in Fowlerville," Feig added. "John was an active member for a long time with Livingston County Fire investigation team. This was in addition to his regular job with the Livingston County Building Department.

Livingston County Veteran Services highlights agency's impact during 2025

In 2025, Livingston County Veteran Services (LCVS) made a meaningful difference in the lives of local veterans and their families through its Veteran Assistance Programs, funded by local millage. These programs, which provide food and clothing vouchers, dental assistance, emergency shelter, utility relief, transportation, and burial reimbursement, continued to serve as a critical lifeline for those who served our nation.

Throughout the year, LCVS provided emergency relief assistance to 124 veterans and their families, helping them meet urgent needs during times of hardship. Access to healthcare remained a priority, with 10 veterans participating in the VINA Community Dental Program, where LCVS covered dental services totaling \$2,130. Transportation assistance also played a vital role in supporting veterans' well-being. In 2025, LCVS provided 2,250 transportation rides, ensuring veterans and their spouses could attend essential medical appointments and access critical services. The total value of these rides amounted to \$19,387.

LCVS placed special emphasis on supporting veterans during the holiday season. At Thanksgiving, the department

purchased Meijer food-only gift cards, providing one card per person in each veteran household so families could shop for ingredients to prepare a home-cooked holiday meal. In total, more than 50 gift cards were distributed. During Christmas, LCVS partnered with Gleaners Community Food Bank to further assist veterans in need. LCVS purchased and distributed 100 holiday food baskets, each complete with a frozen ham and all the fixings, ensuring veterans and their families could enjoy a warm and festive holiday meal.

LCVS Veteran Service Officers continued their advocacy work, processing more than 2,000 claims to the U.S. Department of Veterans Affairs (VA). These efforts helped veterans and surviving family members access the benefits they earned through their service. According to the National Center for Veterans Analysis and Statistics Geographic Distribution of VA Expenditures Report, Livingston County Veterans collectively earned an estimated \$259,694,602 in VA benefits in 2025. These expenditures span key program areas, including Compensation and Pension, Dependency and Indemnity Compensation, Survivors Pension, Insurance, Memorial Benefits, Education and Vocational Rehabilitation & Employment, and Medical Expenditures.

"These programs reflect our ongoing commitment to

honoring and supporting those who have served," explains Ramon Baca, Director of Veteran Services. "This work is made possible through the continued investment and support from our community. We're proud to have made a difference in our community in 2025 and look forward to what we can accomplish in 2026."



Rare flower readies for spring blooms amid winter slumber

While most of Michigan's native plant species are hunkered down for the season, a rare winter flower, yellow fumewort, is living its best life in parts of southwest Michigan. This introverted plant avoids competition by completing its life cycle in the winter, when there is less crowding and shade from other plants.

"It sprouts from seed in August and grows leaves that look similar to Dutchman's breeches in the fall as the daylight shortens," said DNR endangered species biologist Amy Bleisch. "Yellow fumewort spends the winter with its leaves on and then blooms pale, yellow flowers in April. After setting seeds, the plant dies, and the next generation grows again in the fall."

Bleisch said yellow fumewort (*Corydalis flavula*) is listed as threatened in Michigan, meaning it is at future risk of becoming endangered.

"Now present in just three counties here – Berrien, Calhoun and Kalamazoo – the sprawling annual plant used to thrive throughout the Kalamazoo River floodplain," she said. "Yellow fumewort lives on forested stream slopes and bluffs throughout its range, which stretches from Rhode Island to Florida and Michigan to Louisiana."

Michigan is home to more than 400 species of threatened or endangered plants, fish and animals. Like yellow fumewort, many of these species are rare because they can live only in specific habitats and places. Many can be found in only a few counties. Often, they can be seen or heard during just a few weeks each year.

"It's rewarding to dig into the details and origins of the plants and animals that are native to our state, because so much of what you find in the great outdoors is a big part of what makes Michigan Michigan," Bleisch said. "You never know, something cool could be living near you!"

Innovative Revolutionary War Exhibition is a Collaborative Project of the American Battlefield Trust and the National Society Daughters of the American Revolution.

The Philip Livingston Chapter is excited to announce the opening of the *American Revolution Experience* at Hamburg Township Library beginning February 9, 2026. The innovative pop-up exhibition includes display panels and interactive digital kiosks that use storytelling, illustrations, technology, unique artifacts and primary accounts to connect modern audiences with the people and places that shaped the birth of our nation. Created through a collaboration between the American Battlefield Trust and the National Society Daughters of the American Revolution, the exhibit is also made possible by generous matching funds from the National Park Service's American Battlefield Protection Program battlefield interpretation grants.

The exhibit will run from February 9 - 14 at the Hamburg Township Library, 10411 Merrill Rd., Hamburg, MI. The exhibit hours are Monday-Thursday from 9am-8pm; Friday 12-6pm; and Saturday 9am-3pm.

The *American Revolution Experience* launched online in its first digital-only iteration during the summer of 2022 to rapid acclaim and received a Bronze Award in the Education, Art, & Culture division of the second annual Anthem Awards, an initiative of the Webby Awards celebrating purpose and mission-driven work. these individuals today. Both online and on-site, the American Revolution Experience features custom illustrations by South Carolina-based artist Dale Watson. The exhibit also draws from documents and objects in DAR's collection, as well as the Trust's industry leading digital interpretation resources.

"Independence may have been declared in Philadelphia by the Declaration's 56 signers, but it was hard-won on the battlefields we protect by the thousands of Patriot soldiers from whom today's Daughters trace descent," said Trust President David Duncan. "Together, our organizations bear witness to the fact that we are not so far removed from those impactful events, that there are meaningful ways to bridge those 250 years."

The *American Revolution Experience* invites visitors to consider the choice faced by members of the revolutionary generation as tensions mounted in the 1770s: Would these ordinary citizens risk their lives and livelihoods in pursuit of liberty? Or would they remain loyal subjects of the British crown, coming into conflict with neighbors and family? Michigan House Report

Putting Students First by Reducing Classroom Distractions

Recently, I voted yes on a bill that limits cell phone use during instructional time in Michigan classrooms while preserving local control for our schools.

Smartphones are a part of everyday life, but in the

classroom, they can too often pull students' attention away from learning. Parents and educators have raised real concerns about constant notifications and digital distractions interfering with instruction, and this bill takes a practical, balanced approach to addressing that challenge.

House Bill 4141 requires schools to restrict cell phone use during class, but it does not impose a one-size-fits-all mandate. Local districts retain flexibility to decide how policies are enforced whether phones remain on students, are stored in lockers, or are managed at the classroom level. Students learn best in environments that are focused, structured, and free from unnecessary distractions. When instruction is interrupted by distractions, students lose valuable opportunities to develop essential skills. This plan is about giving students the best possible learning environment where they can engage with their teachers, collaborate with classmates, and fully participate in their education.

The bill also includes clear exemptions for medically necessary devices, district-issued technology, academic use at a teacher's discretion, and accommodations for students with IEPs or 504 Plans. Emergency use is also permitted when it does not interfere with safety procedures.

Technology can be a valuable tool when used intentionally, but during instruction students deserve an environment where learning comes first. That's why I supported and voted for this plan to help students stay focused and give schools the flexibility they need to succeed.

- 3/17/2026-3/23/2026 HIV/AIDS and Sexual Harassment/ Technology Safety


