NOTICE OF HEARING OF INTENTION TO RELEASE EXCESS EASEMENT

Grand River, Suite 105, Howell, Michigan, any interested property owner may appear to protest said release of excess easement. The easement to be released and re-conveyed to the present owner of record is described as follows:

A 80-foot wide permanent easement which traverses Tax Code No. 05-29-200-005, 05-29-200-019, 05-29-200-022, granted by William and Emilie Luitze, and further described as follows: Beginning at the NE corner of Section 29 within the intersection of Judd and Nicholson Roads, thence N 89°58'11" W, 1457.01 feet to the point of beginning of the easement to be released; thence S 1°29'58" E, 166.08 feet to a point "A"; thence S49°14'59"W, 531.3 feet; thence S7°44'17"E 808.91 feet; thence S0°20'12"W, 663.15 feet; thence S16°30'22"W, 481.36 feet; thence S4° 59'55"E, 66.0 feet; thence S26°59'57"W 132.0 feet. Also a branch drain described as follows: Beginning at a point "A" as previously referenced, thence S0°30'0"E, 1148.40 feet, thence S90°0' W, 303.6 feet to the point of ending of said branch.

If no protests are received, this 80-foot easement which was utilized in the original construction of the Handy No. 7 & 13 Drain and is not needed for future improvements will be relinquished in full to landowners of record.
