#### 'Wreaths Across America' planned at Greenwood Cemetery Saturday, Dec. 13

The Fowlerville Fourth of July Committee is proud to announce that they are sponsoring the 8th Annual 'Wreaths Across America' on Saturday, Dec. 13, at the Greenwood Cemetery in Fowlerville.

The program will start at 12 noon, with the gates open at 11 a.m. The noontime start will coincide with the ceremony at Arlington National Cemetery and similar events at over 4,225 other locations in all 50 U.S. states, at sea and abroad. Each ceremony is as varied as the men and women it honors with speakers, moving sentiments, pageantry and often music. One thing every ceremony has in common is the placing of wreaths on grave sites to honor those who have served, many offering the ultimate sacrifice while serving this nation. On that day more than two million of them will be placed.

The approximate hour-long ceremony in Fowlerville will include remarks by Laura Goldthwait, the Commander of American Legion Post 141, and State Rep. Jason Woolford, a U.S. Marine Corps veteran. Pastor Robert Storey of the Place of Refuge will serve as chaplain.

Fourth of July Committee member Melissa Salgado will serve as the emcee.

The ceremony will be highlighted by the laying of wreaths honoring all of the military service branches (Army, Navy, Marine Corps, Air Force, Coast Guard/Merchant Marine, Air Force, and National Guard) as well as law enforcement & first responders, MIA/POWs, and Gold Star families. Special recognition will be given this year to the Special Forces.

There is no charge for this event. Veterans, their family and friends and the general public are all welcome to attend.

Donations to the Wreaths Across America Fowlerville celebration can be made at the Village of Fowlerville office. A wreath costs \$17, with the local group receiving \$5. This money, noted Committee member Mary Helfmann, is used to purchase wreathes for next year's ceremony. Wreaths that people have already purchased for this year will be available at the event to lay on veterans gravesites.

#### Fowlerville Community School News FCS Received Unmodified Audit Result

Fowlerville Community Schools has received an unmodified opinion on its annual financial audit. Also referred to as a "clean opinion," this is the most favorable outcome of an audit. A clean opinion maintains the district's eligibility for current and future state aid, Title I, special education and other critical programs. Auditors found there were no material weaknesses and no significant deficiencies.

The audit was conducted using the draft 2025 Compliance Supplement, as the federal government has not yet issued the final version. No changes are expected between the draft and final documents.



Fowlerville Community Schools has an 11.92% fund balance. The audit was performed by Maner Costerisan and reflects our district's ongoing commitment to strong financial stewardship and responsible use of taxpayer dollars.

#### Personal Communication Devices (PCD) Policy Reminders

Fowlerville Community Schools remains committed to creating a safe, focused and engaging learning environment where every student can thrive. As part of this effort, and in response to what we continue to learn about the impact of personal technology on student well-being, the Board of Education approved Phase 1 revisions to Policy 5136 Personal Communication Devices (PCDs), which are now in effect. These updates apply to all students in grades pre-K through 12. **Under the revised policy, the following changes were made:** 

- The definition of PCDs now includes smartwatches, AirPods/earbuds, headphones and other wearable technology, in addition to phones, tablets, laptops and similar devices.
- Grades pre-K through 5: Student use of PCDs is now fully prohibited during school hours, and devices must remain turned off and stored in a locker, teacher basket or backpack.
- Revised Policy 5136 allows only one approved way for pre-K through grade 12 student communication during the school day: students must use school phones to contact parents or guardians. Because the policy identifies only this single method and audience, it means students cannot use their PCDs to call, text or message during the instructional day and school phones may be used only to contact parents and guardians.

#### November 18th Policy Committee Recommendations

After reviewing input from students, staff, and families, the Policy Committee unanimously supported forwarding several additional updates to the full Board for first reading on December 9, 2025. These recommendations include:

#### **Revised Wearable Technology Definition**

"Student-owned fitness devices that are not web-enabled and do not connect to the Internet through another device are allowed. These fitness devices must be silenced with no vibration."

#### Pouch Use for Grades 6–12

Based on stakeholder feedback, the committee recommends secure pouch use for grades 6–12, rather than grades 3–12.

## PCDs May Be Turned On (Silenced)

Students may keep devices turned on as long as they remain silenced (no vibration) and properly stored in the appropriate location for their grade level.

## Clarified Communication Expectations

"Students shall use school phones to contact parents or guardians during the school day. Students may use school phones to contact other parties when deemed appropriate by school staff or administration. Students shall not use PCDs to

make calls, send texts, or send messages at any time during school hours."

Thank you for your generosity to those in need. Little Glad Early Learning Preparing for Move to H.T. Smith Building

Little Glad Early Learning, which will be transitioning to the H.T. Smith building, currently has a target move date of January 20, 2026. Staff are busy boxing up items, and the construction crew is finishing up projects.

Recent updates include:

- Playground fencing was installed last week, making our new outdoor play space much larger, providing a designated area for children ages 18 months to 3 years old, as well as concrete areas for ride-on toys.
- Kitchen updates are nearing completion.
- Classroom furnace enclosures are in the final stages of completion.

Throughout this process, we will submit all required inspection and occupancy permits and work closely with Child Care Licensing to ensure the move happens as smoothly as possible. ### Proposed ban on Personal Communications Devices during school day getting pushback from some parents

A proposed ban on the use of personal communications devices (PCDs) during the school day, including locking up those possessed by older students in a pouch from the time they arrive at school until they leave, is on track to be approved by the Fowlerville Board of Education. However, both the pace at which it is happening and what's being proposed is getting pushback from some parents as well as students.

The proposal was first announced by officials earlier this fall, with the details being outlined in the 'Gladiator Gazette', a newsletter that's e-mailed to parents and school staff every other week. Much of the 'Gladiator Gazette' is also published in the 'Fowlerville News & Views'. Those details included why changes to the current policy on PCDs were being looked at and the process that would be in place for doing so.

Specifically, the board was looking at two phases.

Phase One was expanding the definition of a PCD be-

yond the current cell phone to include wearables like smart watches, smart glasses and ear buds and that students could no longer utilize these devices during the school day, unless granted permission by a teacher or administrator. This prohibition included using them to contact anyone, including parents or someone at home. Students wishing to call home, under the new policy, would need to do so from the phone in the school office. Parents could also contact the office to leave a message.

Phase Two, and the more controversial one, would make the school device-free during the classroom day by prohibiting students from possessing any active PCDs during their time in school—called a bell-to-bell ban. Younger elementary students would power them off at the start of the day and place them in their locker or backpack, while the older students would have any phones and wearables locked in a pouch upon their arrival. The pouch would stay with the student but remain inaccessible during the day, then unlocked at the end of the day at designated stations.

As to 'why', officials stated in the opening paragraph of their announcement that "Fowlerville Community Schools is committed to providing a safe, focused, and engaging learning environment for all students that optimizes learning and supports their success."

To back this up, they said that "This approach has been

shown to support student focus, academic achievement, and well-being," noting an "86% improved students safety and wellness, 84% increased classroom engagement, 68% academic gains, and 44% fewer behavioral referrals."

Since then a First Reading was held by the board at its Oct. 14th meeting on the Phase One changes, followed by a Second Reading and Adoption of the Updated Policy at the board meeting on Nov. 11<sup>th</sup>.

During this time, parent forums were held to explain the changes and the reasons the board and administration were pursuing them, a survey was sent out to gain feedback, and a board of education policy committee was held last month to take feedback and make a recommendation. What's up next, if the steps are taken, is a First Reading of the Phase Two proposal (ie ban) at the board's upcoming meeting this Tuesday, Dec. 9th, a board policy committee meeting on Dec. 15th, and the Second Reading and Adoption of Policy at the Jan. 6th board meeting. If approved, then the Personal Device-Free School Day Launch would be targeted for the start of the second se-

mester on Jan. 20th.

In an interview with WHMI Radio done after the Phase One adoption, Superintendent Matthew Stuard said that "the moves stem from a lot of different reasons, including a decline in engagement in FCS classrooms and also for safety and security purposes."

"Our safety and security personnel, including our local police chief, have talked to us about needing our kids to be focused during emergencies," he said, adding that overloading the 911 emergency response system could cause problems with response.

"We've just seen nationally an uptick in mental health issues related to cell usage, bullying, and cyber bullying," he added

Stuard said the board had been talking about this move for a long time and pointed to Pinckney and other school districts (including Webberville) having adopted similar policies and legislation introduced in Lansing that would require all Michigan districts to adopt similar bans.

#### PUSHBACK FROM SOME PARENTS

But not every parent in the Fowlerville School District supports the policy changes, citing reasons why they feel a total ban and other restrictions on PCD use during the school day are not a good idea or at least need to be studied further. They feel the pace of the changes have occurred too fast, that their concerns are being ignored or brushed off, that they've had too little time during the 'Call to the Public' or at the forums to ask questions and register their disagreement, and they question whether banning PCDs is considered the best way to address such issues as mental health, cyber bulling, and safety issues that school officials have cited rather than other approaches.

They also note that "we live in a technologically changing world that includes PCDs" and that incorporating them into the learning process rather than banning them is a better path forward for students. They further noted that the realities of families with two working parents results in changed plans and also that students and parents see a cell phone as a lifeline in the advent of a school shooter or other threats.

To support their objections and concerns, they point to the findings of a Parent Survey and a Student Survey conducted on the Fowlerville Parents Facebook Page as well as comments users have posted. The findings of these surveys and their interpretation were sent in a packet to the 'Fowlerville News & Views.'

#### The following is under the heading of 'Why We're Here' Proposed PED Policy Changes: Lack of Transparency & Community Input

The Fowlerville School Board is unilaterally advancing major changes to the Personal Electronic Device (PED) policy without reason, meaningful parental involvement, or a transparent process. The proposal has moved forward too quickly:

- Parents were not permitted to speak or express opinions as a "forum" would suggest at the district forum. More accurately, it was a presentation.
- Information presented to families was inconsistent and often misleading.
- Policy details shifted during the process, creating confusion.
- At the board meeting prior to the vote to change PED language (Phase 1), parents were not given a meaningful opportunity to speak or provide input.

As a result, many families feel the process is extreme, has been rushed, the district's parent survey was leading and biased, and the overall approach has disregarded community perspectives and circumstances.

#### We're Here

"bell to bell" full day PED ban, and proposed purchase of device locking Yondr pouches (or similar product).

- While the board stated that this policy change was about mental health and safety while removing distraction and improving test scores, parents would like to highlight the actual concerns our students are experiencing every day – concerns that deserve attention, resources, and honest discussion.
- To give students and families a voice in decisions and providing feedback about what is directly affecting their safety, learning, and mental health.

Participation, they said, included 204 parents and 146 stu-

A lot of detailed data was provided and shown in various graphs—more than space allows in this article.

Of interest, though, is the key takeaways they feel are shown from the responses that were given:

- 1- A clear majority of both parents and students express opposition to the district's proposed Personal Electronic Device restrictions.
- 2- Many participants shared concerns about how the proposal was introduced, the lack of authentic avenues for feedback, shifting information, and the speed of implementation. This has affected trust and confidence in the decision-making process.
- 3- Parents highlighted real issues that need attention. Feedback revealed significant concerns about mental health, academic pressure, bullying, school climate, safety, and the need for stronger support systems areas that extend far beyond the personal electronic device policy discussion.
- 4- The data suggests resources should be redirected toward these core issues. Based on community input, families overwhelmingly believe that investments should focus on student well-being, mental-health resources, consistent classroom support, and addressing behavioral challenges, rather than implementing a restrictive ban.
- 5- The surveys provided a transparent, unbiased view of community sentiment. With large voluntary participation, the results reflect meaningful community perspectives that should guide responsible, studentcentered policy decisions.

To celebrate the start of the month, the Michigan Department of Agriculture and Rural Development (MDARD) and the Michigan Christmas Tree Association (MCTA) toured Peacock Road Family Farm in Laingsburg.

"Real Michigan Christmas trees are a holiday tradition for many families, whether you visit a Christmas tree farm or a retail tree lot," said MDARD Director Tim Boring. "You not only get a fresh, fragrant, beautiful tree as the centerpiece of your celebrations, but at many locations you also get to experience activities like hayrides or sleigh rides, petting farms, visits with Santa and more. We continue to see that Michiganders are interested in connecting directly with

agriculture, and establishments like Peacock Road Family Farm are really the fabric of our state culture this time of year."

Michigan's integrated network of family farmers, processors, wholesalers and retailers work together to ensure a quality product celebrated by millions throughout our state and country.

The state ranks third in the nation for the number of Christmas trees harvested, supplying about two million fresh trees - with an annual net value of more than \$45 million - to the national market each year. There are more than 500 Christmas tree farms on a combined 33,000 acres in Michigan, ranging from large wholesale farms, to choose and cut farms, to small farms with a few acres selling precut trees.

"Michigan's Christmas tree industry delivers more than just holiday cheer," said Amy Start, Executive Director of MCTA. "It generates jobs, supports environmental sustainability, and provides joy to millions of families during the holiday season. It means a lot to know Gov. Whitmer supports our industry and celebrates our role as a memory maker for Michiganders."

Michigan grows and sells more than a dozen Christmas tree varieties on a wholesale level, which is more species than any other state. In addition to Christmas trees, the industry makes an additional \$5 million in sales of wreaths, cut boughs, garland and other fresh greenery products.

"The holidays are always a magical time at Peacock Road Family Farm, and we're excited to welcome families back to the farm this Christmas season," said Farm General Manager Christian Voorheis. "You can take a wagon ride out to the field to cut your own tree or choose from our pre-cut lot and visit Santa in his cabin, roast marshmallows at a firepit, sip cocoa, buy lunch or a snack, visit our Christmas store, and leave with a beautiful Christmas tree, a warm heart and lasting holiday memories."

Real Christmas trees are also a great environmental choice. They grow on rocky soil typically unsuitable for other crops and provide extra woodland for animals, create oxygen, and take carbon dioxide out of the air, helping combat global warming. Christmas trees are renewable resources and 100 percent recyclable. The best way to recycle your tree after Christmas is to chip it into mulch, which can be used for landscaping projects.

Christmas trees take six to eight years to reach marketable height. For every Christmas tree harvested, Michigan growers plant three new trees for future harvests.

# ORDINANCE NO. 501 ORDINANCE AMENDING SECTION 612 OF ORDINANCE NO. 346

The Village of Fowlerville ordains:

**Section 1.** Section 612, Fences, walls and screens, Chapter 6, *GENERAL AND SUPPLE-MENTARY REGULATIONS*, of Ordinance No. 346, entitled "Zoning Ordinance of the Village of Fowlerville, Michigan" is hereby amended to read as follows:

#### Sec. 612. - Fences, walls and screens.

No fence, wall or structural screen, other than plant materials, that encloses residential property shall exceed six feet in height. No fence, wall or hedge plantings shall exceed a height of three feet within any residential front yard within an area closer than 20 feet to the street right-of-way line. On any corner lot or parcel, no fence or planting shall exceed a height of three feet within 20 feet of any corner so as not to interfere with traffic visibility across a corner. No fence, wall or hedge planting shall encroach upon a public right-of-way or sidewalk. If the principal structure is closer than 20 feet to the street right-of-way line, no fence, wall, or hedge shall exceed a height of three (3) feet beyond the front wall of the principal structure.

<u>Section 2. Validity and Severability.</u> The provisions of this Ordinance are severable and the invalidity of any phrase, clause or part of this Ordinance shall not affect the validity or effectiveness of the remainder of the Ordinance.

<u>Section 3</u>. <u>Repealer Clause</u>. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed only to the extent necessary to give this Ordinance full force and effect.

<u>Section 4.</u> <u>Savings Clause</u>. This Ordinance does not affect rights and duties matured, penalties that were incurred, and proceedings that were begun, before its effective date.

<u>Section 5</u>. <u>Effective Date</u>. This Ordinance shall be effective seven (7) days from and after its publication.

## Village of Fowlerville Businesses and Residents Reminders:

Please be advised the Village of Fowlerville Ordinance for Snow and Ice Removal is as follows:

#### **Snow Emergencies**

During a **snow emergency**, all vehicles **must be removed from the streets** to allow for safe and efficient plowing

Vehicles not moved may be ticketed and/or towed at the owner's expense.

#### Sidewalk Snow and Ice Removal Ordinance

All owners or occupants of properties must remove snow and ice from sidewalks adjacent to their lots according to the following time frames:

- Within 24 hours after a snow or sleet storm ends, if the storm produces
   4 inches or less of snow or precipitation.
- Within 48 hours after a snow or sleet storm ends, if the storm produces more than 4 inches of snow or precipitation.

If a property owner or occupant fails or refuses to remove snow and ice from the sidewalks **adjacent to and abutting upon such lot, lots, or premises** within the required time frame, the Village Manager or their designee may arrange for the removal. All costs incurred for this service will be billed to the property owner.

#### DO NOT PLOW OR SHOVEL INTO OR ACROSS THE STREET

It is **illegal under Michigan State Law (Section 257.677(a)** of the Michigan Vehicle Code) to shovel or plow snow or ice **onto any street, road, or highway**, or to deposit snow in a way that **blocks motorists' view of traffic**.

#### **Avoid the Second Shovel**

When shoveling your driveway, plan ahead! If no space is made for the plowed snow to go, the passing snowplow may push snow **back into your driveway**. Creating a **designated snow area** can save time and frustration later.

- Do not shovel snow back into the street.

### ORDINANCE NO. 502 ORDINANCE AMENDING **SECTION 620 OF ORDINANCE NO. 346**

The Village of Fowlerville ordains:

Section 1. Subsection 7, Storage Area(s) and Garages, of Section 620, Supplementary dwelling regulations, Chapter 6, GENERAL AND SUPPLEMENTARY REGULATIONS, of Ordinance No. 346, entitled "Zoning Ordinance of the Village of Fowlerville, Michigan" is hereby amended to read as follows:

- 7. Storage Area(s) and Garages.
- a. The dwelling shall contain storage area in a basement located under the dwelling, in an attic area, in closet areas or in a separate structure of standard construction, similar in exterior appearance to the principal dwelling. Such storage area shall contain a floor area not less than 15 percent of the minimum floor area required for that district.

b. All dwellings, constructed after the effective date of this ordinance, shall have an attached or detached garage. Attached and detached garages must comply with all applicable ordinance provisions.



#### Rep. Bollin wants to take closer look at work projects; dismisses time concerns

House Appropriations Committee Chair Ann Bollin wants to take the remaining legislative time left in the year and put it to use on an endeavor that's long been a governmental "sore spot" to her: reviewing departmental work projects in a more transparent and meticulous way than usual.

That's why she directed her appropriations subcommittee chairs to seek further information on work projects from the departments within their purviews, Bollin, R-Brighton, told Gongwer News Service in response to letters obtained earlier this week from one such subcommittee chair, Rep. Tom Kuhn, R-Troy, putting a hard deadline on his departments to justify their work projects.

Bollin said it's been a priority of hers for many years to retool the process for non-statutory work projects, which take effect automatically 75 days after the end of the fiscal year unless lawmakers in appropriations committees vote to reject them. This year, as part of the budget process, Bollin directed

her subcommittee chairs to review the projects at two separate points in the year.

"Looking at the work projects has been on my radar and is one of the sore spots to me since I've been a legislator, and in particular (since I became) appropriations chair," she said. "In the very beginning of the year, I asked all my subcommittee chairs, and included myself, to review all the existing work projects and get a feel for where they stood. And post-budget, I asked (them) to dig in again and see if (departments) made progress from the first time you met with them, knowing that the State Budget Office would make a recommendation, which is typical."

Kuhn, who chairs the House Appropriations General Government Subcommittee, stirred some panic amongst the departments his committee oversees when he seemed to abruptly push up a deadline for them to meet with his office from Dec. 8 to Nov. 26. In his first letter to the departments, he said he would recommend his members vote to reject the work projects of any department that did not meet with him or whose presentations were "incomplete or inadequate."

The deadline push ahead of Thanksgiving drove concern

#### **Traditional Cremation:** Why it's my personal favorite option

Last week, I shared how excited I was to talk about traditional cremation — and for good reason. This option blends the meaningful structure of a traditional funeral with the flexibility of cremation. For many families, it truly offers

the best of both worlds.

What sets traditional cremation apart is the opportunity to view your loved one before the cremation takes place. This is something the other cremation options simply don't provide. Viewing offers a kind of closure that can't be replicated in direct cremation or a memorial service alone. There's something deeply healing about seeing your loved one at rest, taking a moment to say goodbye, and allowing your heart to begin processing the reality of the loss. Time after time, I've watched families walk into a viewing carrying a heavy emotional weight — and walk out with a sense of peace they didn't expect.

A common question families ask is about the casket used for this option. Most funeral homes, including ours, offer a rental casket specifically for traditional cremation. And just to clear up a worry many people have: only the outer shell of the rental casket is reused. Inside is a completely new insert

designed for cremation, made of materials that are cremated along with your loved one. All interior fabric and anything that touches your loved one is *never* reused. This setup gives families a dignified and traditional presentation without requiring them to purchase a full casket they don't need long-

And for families who prefer something different, there are options to upgrade the casket. Yes — even metal caskets can be cremated. Many people are surprised to learn that. Because metal caskets require higher heat and can be harder on crematory equipment, they're often cremated at the end of the operational day. This gives the crematory time for proper cool-down and maintenance before the next day begins. It's a safe and respectful process, and it's absolutely an option if the family chooses it.

Traditional cremation is a meaningful choice for families who value the healing nature of a viewing and funeral service but appreciate the flexibility cremation provides afterward. It combines ceremony, connection, and closure in a way that honors both tradition and practicality.

And just as I've said before, you will very rarely hear me tell a family what they should do. That's not my place. ### Rep. Bollin wants to take closer look at work projects, continued

among departmental staff that if they were unable to accommodate Kuhn's requests due to holiday season absences, they would have work projects canceled.

Bollin acknowledged the busy nature of the end of the year but said the timeline set in statute, as well as the constitutional end to the fiscal year, guarantees any review of work projects would take place at a hectic time – something she said departments

"The expectation is that I work every day as a representative, okay? And the timeline is the timeline, the fiscal year ends on September 30," she said. "It's not likely to change, so everybody should be really kind of preparing themselves for it."

Bollin said several departments across state government have already offered additional information or met with subcommittee chairs without concerns. Those making claims to be unable to fulfill the chairs' requests, she said, "sound like bureaucrat back-talk."

In the House Appropriations Committee, which Bollin said she plans to convene Dec. 10 for votes on work projects, there's a bill to require legislative approval for work project appropriations and prohibit the expenditure of the funds under certain circumstances. HB 4800, introduced by Bollin back in August, would be one step in reforming a process she believes needs to be changed in the interest of better financial accountability and transparency on the state's behalf.

"When we were developing this year's budget, we found over \$6 million worth of work projects on the books. And that's a lot of money to be socking away," Bollin said. "And sometimes there's an absolutely legitimate reason why they need to be carried forward, (but) then sometimes it just looks like departments are trying to sock money away, or they're really trying to provide a path for staffing. And work projects are supposed to have a specific purpose, and they are supposed to give us an outline of what they're going to be used for, the timeline and the cost and the reporting is very different for every department."

## Lawmakers eyeing more restrictions on internet gaming & online sports betting advertising

By Finn Mills **Capital News Service** 

Two new bills would tighten guidelines for Internet gaming and online sports-betting advertisements.

The bipartisan bills aim to curb gambling addiction by requiring placement of the toll-free gambling addiction hotline number as well as the legal gambling age within the advertisements.

The sponsors are Democratic Sens. Erika Geiss of Taylor, John Cherry of Flint, Dayna Polehanki of Livonia, Rosemary

Bayer of West Bloomfield and Mary Cavanagh of Redford Township, as well as Republican Sen. John Damoose of Harbor Springs.

The goal is to ensure that Michigan's gambling industry "operates with the utmost integrity and accountability," according to Geiss.

Under the bills, if a company breaks the regulations, it would be fined \$1,000 for the first offense, \$5,000 for the second offense and have its gaming license revoked after the third offense.

These bills would also allow municipalities to set their own rules and regulations for how Internet gaming and online sports betting are advertised in their areas.



Geiss said that online gambling is "addictive and coercive" and compared online gambling advertisements to the way cigarettes used to be advertised.

She noted that things such as flashy lights and visuals and celebrity endorsements are often added to make their products more appealing to younger people, thus leading to more addicted customers.

"These marketing campaigns often glamorize gambling, downplay the dangers and reach impressionable audiences who are far too young to participate," Geiss said.

These bills have been referred to the Committee on Regulatory Affairs.

I read a transcript of the book by Ms. Houselander and she said "Strangely those who enough, complain the loudest of the emptiness of their lives are usually people whose lives are overcrowded, filled with trivial details, plans, desires, ambitions, unsatisfied cravings for passing pleasures, doubts, anxieties, and fears. Those who complain as such are usually afraid of the space or silence or the pause in their life which we need. We are afraid and dread it because of what I spoke of above, we don't want to hear our own pulses beating out the seconds in our life."

must embrace the silence.

If you believe you don't have time to be silent, reevaluate. The multiple alarms and notifications, or the requests and obligations the world is set up against simple, silent and still. Yet if we can just allow ourselves the time, we know we may stir up something, something deep that makes us really think about what is happening in our lives.

Be prepared, because as much as I know that I don't like all the noise every day, I don't know what I would do without it. It has been a part of mine and your life for so long we are dependent. But this Advent, I would like to have you try and sit in silence. It may never be longer than a few minutes or it could blossom into 15 or even 30 minutes, but try to do it and see what happens.

There is a prayer, very simple, called the Jesus Prayer that goes like this:

Jesus Christ, Son of God, my soul waits for You in the stillness

Each time you feel overwhelmed, distracted or afraid say this, whether it be once or 1,000 times a day. During this time, listen, open your heart, ears and mind and see what you can make from it, what you hear. It just may surprise you.

Oh, I almost forgot... Listen to the song 'Sound of Silence'. I mean LISTEN to the song. You'll understand why silence isn't a treasured event, yet in all the business we actually do nothing.



Reflecting back on a Christmas season in my fifth grade class, where art projects were created under the guidance of our primary teacher, this particular year Miss McKenzie taught us how to make a simple–and by no means elegant–Christmas wreath.

I'm pretty sure each one of us kids in her classroom provided our own coat hanger. As was custom in her class, every Friday afternoon was dedicated to art. This meant that when we returned from lunch break, we had about two glorious hours to focus on working with our hands to create art projects that came alive using simple materials.

Making our wreath involved twisting and shaping our wire clothes hanger into a good circle—no wood or plastic ones would host this project! Layers and layers of red and green tissue paper were then gently torn or crudely cut to form strips of paper that we twisted around the wire, pushing each strip close to its neighbor until the entire circle was full. Then, we checked our final work, fluffing and adjusting each strip where necessary. Ribbon to form a bow was provided by our teacher as well, giving our wreath its final touch.

My hope is that passersby enjoy the beauty of its glow in night skies and all who enter our home feel welcomed and loved, enjoying hospitality blanketed under the beauty of the Advent season.

As much as I love having our modern wreath I admit a bit of melancholy emotions rise inside me as I think back how my simple 5th grade tissue paper wreath didn't survive from year to year, yet as it eventually made its way to being discarded, the memories still linger and fill my heart with great joy.




