- to consider an amendment to the Zoning Ordinance imposing a temporary moratorium on wind and solar energy projects in the Township;
- to consider an amendment to the Zoning Ordinance repealing the existing provisions regulating solar farms and solar buildings, including sections 13.17, 13.27, 4.03(M), 5.03(L), 5.03(K), 6.03(K), 7.03(H), 10.03(G), 11.03(X), and 16.58(C), and removing the definition of "Solar Farm" from section 2.02 of the Zoning Ordinance; and
- to consider any other business that lawfully comes before the Planning Commission.
